

**NOTICE OF SPECIAL MEETING OF THE GOVERNING BODY

PUBLIC HEARING ON FYE 2027 PROPOSED OPERATING BUDGET &  
PROPOSED 2026 PROPERTY TAX RATE**

Notice is hereby given that a **Public Hearing** of the Governing Body of the City of Slaton, Texas will be held on the **24th** day of **August, 2026** at **6:00 p.m.** in the City Hall, 130 S. 9<sup>th</sup> Street, Slaton, Texas, at which time the following items will be considered and acted upon as deemed necessary, to-wit:

**The budget will raise LESS revenue from property taxes than last year's budget by an amount of \$64,408.26 which is a 3.03% DECREASE from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$2,995.67**
