This led to the arrest of the individual living in the home, along with his girlfriend, both were transported and booked in Lubbock County Detention Center. 21. Oath of Office for Mayor and Commissioner Ward 1 Keith Creager:

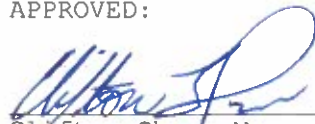
