5. EXECUTIVE SESSION: The City Council will convene into closed session in accordance with Texas Government Code, Section 551.071 - Consultation with Attorney:

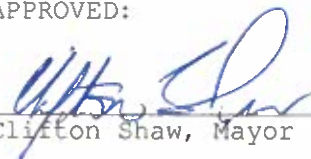
Mayor Shaw closed the Special Meeting at 6:05 p.m.
